By using the Sites, subscribing to Nelson Hotels or interacting with us on social media you are accepting and consenting to the terms of this policy.

Nelson Hotels (Company number; 1626524) is the trading name of Nelson (Northwest) Hotels Ltd, which is a registered company in England and Wales. Nelson Hotels are the owners and operators of the Sites and the relevant accounts on the social media. Nelson Hotels' registered office is: Grosvenor Pulford Hotel, Wrexham Road, Pulford Ch4 9DG.

We are committed to maintaining your privacy. We reserve the right to amend these Terms from time to time. The Terms were most recently updated on 1st May 2018.

Information we collect about you:

During your use of the Sites (including browsing), your registration, your interaction on the social media we may collect and process the following information about you:

Information you give us.

- When signing up to our newsletter we ask for your name and email address, in order to contact you about interesting deals, news and events, as promotion of our services.
- You may also give us information about you when making a booking, making an enquiry or
 requesting information about our services and filling in forms on the Site or when you
 correspond with us on the Social Media for example when you enter into our prize

 particular offers or when you participate in our Social Media activities or surveys. In
 such circumstances you may provide additional information about you such as a

 and hobbies, details of your Social Media accounts, posts and preferences.

You must ensure in all instances that the information you provide is personal to you and no
one else (for example you must only provide an email address that is only accessible
by you and not any other person. You should not use another person's email address
or a generic email address). You must also ensure that the information you provide is
accurate and up to date. By providing information about you to us you warrant that
the information you provide is personal to you and is accurate and up to date, and that
you will keep us informed of any changes.

Information we collect about you.

In accordance with Article 6 of the GDPR we process your personal data, in order to provide you the services of Nelson Hotels, by entering our site and knowingly submitting your personal data you are therefore providing consent.

Web browser cookies

Information you give to us.

We will use this information:

Storing your personal details
